



## **ORDER OF SPECIAL ELECTION**

An election is hereby ordered to be held on Tuesday, November 3, 2020, for the purpose of:

**THE REAUTHORIZATION OF THE LOCAL SALES AND USE TAX IN THE CITY OF SELMA, TEXAS AT THE RATE OF ONE-FOURTH OF ONE PERCENT TO CONTINUE PROVIDING REVENUE FOR MAINTENANCE AND REPAIR OF MUNICIPAL STREETS. THE TAX EXPIRES ON THE FOURTH ANNIVERSARY OF THE DATE OF THE ELECTION UNLESS THE IMPOSITION OF THE TAX IS REAUTHORIZED.**

Hours of Early Voting by personal appearance will be from 8:00 a.m. to 5:00 p.m. on October 13, 2020, through October 23, 2020; from 7:00 a.m. to 7:00 p.m. on October 24, 2020; from 1:00 p.m. to 6:00 p.m. on October 25, 2020; and from 7:00 a.m. to 7:00 p.m. on October 26, 2020, through October 30, 2020, or such times as established by the Guadalupe County Elections Administrator, Comal County Elections Administrator, or Bexar County Elections Administrator.
